When it comes to getting around the Medicaid financial requirements, you can only have more money if you are over 65, a child, pregnant, blind, or otherwise disabled. In general, you can only have income that is not over 138% of the FPL for your size family or household.

### Medicaid Eligibility in New York (NY)

How to qualify for Medicaid. Almost all states have several systems for Medicaid. But, as a general rule of thumb, if you make up less than 100 percent to 200 percent of the level of federal poverty (FPL) and are pregnant, elderly, disabled a parent/caretaker, or a child, you are likely to have a program.

### Medicaid Income Limits 2020: How to Know you are Eligible ...

While persons residing in nursing homes paid for by Medicaid are permitted to have monthly incomes as high as \$2,349 (in most states), those individuals are not permitted to keep that income. Instead all of their income except for a personal needs allowance (which ranges for \$30 - \$150 / month), must go towards paying for their cost of care.

This category has now been subsumed under the new MAGI adult group whose limit is now raised to 138% FPL. Family Health Plus - this was an expansion of Medicaid to families with income up to 150% FPL and for childless adults up to 100% FPL. This has now been folded into the new MAGI adult group whose limit is 138% FPL.
